SBA Disaster Loan Outreach Center in Paulding County to Close October 30

ATLANTA – The U.S. Small Business Administration announces today that the Disaster Loan Outreach Center located in Paulding County, Georgia will cease operations **Friday, October 30 at the close of business.**

The Small Business Administration urges those affected by the severe storms and flooding that occurred September 18, through October 8, 2009, to visit the Centers before the closing to obtain one-on-one assistance and information about the disaster assistance program. The filing deadline to return applications for physical property damage is **November 23 2009**. The deadline to return economic injury applications is **June 24, 2010**.
