SBA DISASTER LOAN DEADLINE IN ALABAMA IS MARCH 22; SMALL BUSINESS OWNERS STILL HAVE TIME TO APPLY

ATLANTA - The U.S. Small Business Administration reminds small businesses affected by the excessive rains and flooding that began in March 2009 in Barbour, Henry, Houston and Russell counties in Alabama of the **March 22** deadline to file applications for loan assistance. The SBA's Economic Injury Disaster Loan program, with loan amounts up to \$2 million with a 4 percent interest rate for businesses and 3 percent for non-profit organizations, is available to entities that suffered financial losses as a direct result of this disaster.

"These counties are eligible because they are contiguous to one or more primary counties in Georgia. SBA recognizes that disasters do not usually stop at the county or state lines. For that reason, counties adjacent to primary counties named in the declaration are included," said Frank Skaggs, director of SBA's Field Operations Center East.

"When the Secretary of Agriculture issues a disaster declaration to help farmers recover from damages and losses to crops, the Small Business Administration issues a declaration to eligible entities affected by the same disaster," said Skaggs. Agricultural producers, farmers and ranchers are not eligible to apply to SBA.

Under this declaration, the SBA's Economic Injury Disaster Loan program is available to eligible farm-related and nonfarm-related entities that suffered financial losses as a direct result of this disaster.

The SBA determines eligibility based on the size of the applicant, type of activity and its financial resources. Terms can be up to 30 years based on each applicant's financial condition. These working capital loans may be used to pay fixed debts, payroll, accounts payable, and other expenses that could have been paid had the disaster not occurred. The loans are not intended to replace lost sales or profits.
