SBA Disaster Loan Deadline in Connecticut is June 21

ATLANTA - The U.S. Small Business Administration is reminding small businesses that **June 21** is the filing deadline for federal economic injury disaster loans that are available in Fairfield and Litchfield counties in Connecticut as a result of excessive rain and hail that began on May 1, 2009. The SBA's Economic Injury Disaster Loan program offers loans up to \$2 million with a 4 percent interest rate for small businesses, small agricultural cooperatives and most private non-profit organizations of all sizes.

“These counties are eligible because they are contiguous to one or more primary counties in New York. The SBA recognizes that disasters do not usually stop at county or state lines. For that reason, counties adjacent to primary counties named in the declaration are included,” said Frank Skaggs, director of SBA's Field Operations Center East.

“When the Secretary of Agriculture issues a disaster declaration to help farmers recover from damages and losses to crops, the Small Business Administration issues a declaration to eligible entities affected by the same disaster,” said Skaggs. Farmers and ranchers are not eligible to apply to SBA.

Under this declaration, the SBA's Economic Injury Disaster Loan program is available to eligible farm-related and nonfarm-related entities that suffered financial losses as a direct result of this disaster.

The SBA determines eligibility based on the size of the applicant, type of activity and its financial resources. Terms can be up to 30 years based on each applicant's financial condition. These working capital loans may be used to pay fixed debts, payroll, accounts payable, and other expenses that could have been paid had the disaster not occurred. The loans are not intended to replace lost sales or profits.

Loan applications can be downloaded from the SBA's website at www.sba.gov/services/disasterassistance. Completed applications should be mailed to: U.S. Small Business Administration, Processing and Disbursement Center, 14925 Kingsport Road, Fort Worth, TX 76155.

Completed loan applications must be returned to SBA no later than June 21, 2010.
