## SBA Disaster Loan Outreach Centers in Plymouth and Suffolk Counties to Close June 10

**ATLANTA** – The U.S. Small Business Administration announces today that due to a steady decrease of activity, the Disaster Loan Outreach Centers located in Plymouth and Suffolk counties, Massachusetts will cease operations **Thursday, June 10 at the close of business.**

The SBA urges those affected by the severe storms and flooding that occurred from March 12 through April 26, 2010, to visit the Centers before they close to obtain one-on-one assistance and information about the disaster assistance program. The SBA also encourages homeowners, renters and businesses who received applications to return their completed applications as quickly as possible. The Centers are located at:

Completed applications should be returned to the Centers or mailed to: U.S. Small Business Administration, Processing and Disbursement Center, 14925 Kingsport Road, Fort Worth, TX 76155.

The filing deadline to return applications for physical property damage is **June 28, 2010**. The deadline to return economic injury applications is **December 29, 2010**.
