SBA Disaster Loan Outreach Centers in Dickson, Dyer and Perry Counties to Close June 17

ATLANTA – The U.S. Small Business Administration announces today that due to a steady decrease of activity, the Disaster Loan Outreach Centers located in Dickson, Dyer and Perry counties, Tennessee will cease operations **Thursday, June 17 at the close of business.**

The SBA urges those affected by the severe storms, flooding, high-winds and tornadoes that occurred from April 30 through May 18, 2010, to visit the Centers before they close to obtain one-on-one assistance and information about the disaster assistance program. There are other Centers that you may visit located throughout the disaster area that will remain open until further notice. The SBA also encourages homeowners, renters and businesses who received applications to return their completed applications as quickly as possible.

The filing deadline to return applications for physical property damage is **July 6, 2010**. The deadline to return economic injury applications is **February 4, 2011**.
