SBA Economic Injury Application Deadline is October 1 for the 2009 Frost, Freeze and Rainfall in Indiana

ATLANTA - The U.S. Small Business Administration is reminding small businesses that **Oct. 1** is the filing deadline for federal economic injury disaster loans that are available in Elkhart, LaPorte, Lagrange, St. Joseph and Steuben counties in Indiana as a result of the early frost, freeze and excessive rainfall that began on Aug. 1, 2009.

“These counties are eligible because they are contiguous to one or more primary counties in Michigan. SBA recognizes that disasters do not usually stop at the county or state lines. For that reason, counties adjacent to primary counties named in the declaration are included,” said Frank Skaggs, director of SBA’s Field Operations Center East in Atlanta.

When the Secretary of Agriculture issues a disaster declaration to help farmers recover from damages and losses to crops, the Small Business Administration issues a declaration to eligible entities affected by the same disaster,” said Skaggs.

Under this declaration, the SBA’s Economic Injury Disaster Loan program is available to eligible farm-related and nonfarm-related entities that suffered financial losses as a direct result of this disaster. Agricultural producers, farmers and ranchers are not eligible to apply to SBA.

The loan amount can be up to \$2 million with a 4 percent interest rate and terms up to 30 years. The SBA determines eligibility based on the size of the applicant, type of activity and its financial resources. Loan amounts and terms are set by the SBA and are based on each applicant’s financial condition. These working capital loans may be used to pay fixed debts, payroll, accounts payable, and other bills that could have been paid had the disaster not occurred. The loans are not intended to replace lost sales or profits.

Completed applications should be mailed to: U.S. Small Business Administration, Processing and Disbursement Center, 14925 Kingsport Road, Fort Worth, TX 76155.

Those affected by the disaster may apply for disaster loans from SBA’s secure website at <https://disasterloan.sba.gov/ela/>.

Completed loan applications must be returned to SBA no later than October 1, 2010.
